Hoe je echte kennis van onwaarheden kunt onderscheiden (How to distinguish true knowledge from false)

## Respected brothers and sisters,

As Muslims living in the West gather today at the Blessed Summit 2024, we find ourselves at a critical juncture. good but may lack proper education and understanding. We can be powerful agents of positive change if we are ambassadors of our faith, focus on our shared values and common humanity, and build strategic alliances with those who share our commitment to justice and equality.

One of the key challenges facing Muslims in the West is the delicate balance between upholding our religious values and navigating the secular landscape of our societies. We must develop the wisdom and discernment to remain true to our principles while actively participating in civic life and contributing to the greater good.
